Notes for changes to the Annual Return (information only)

The total receipts are \$13,700 greater than previously indicated. This is made up of: -

- Two donations of \$7,000 dollars each (Included in the Ruth Greble total of \$82,000) which I had believed were made through the Greens (WA) to Agricultural and Mining and Pastoral Regional groups for the election. I had therefore deducted from the totals believing that the income had already been counted. It has subsequently come to my attention that these donations were provided directly to the groups and should therefore have been counted as additional income.
- I had recorded a donation of \$10,300 for Robin Chapple. \$300 of this was actually a reimbursement of an expense and so the actual amount was only \$10,000

Terms and conditions of interest free loans

Members provided these to the Party for the duration of the Federal election and were reimbursed form the funding paid by the AEC after the election. There was no formal agreement or forms to sign but the terms to members were that

- The loans would be repaid within 2 weeks of receiving our election disbursement from the AEC
- 2. The loans were for the sole purpose of contesting the Federal Election
- 3. The loans were interest free.

All the loans have been repaid.
