## Liberal Party - Notice of Incomplete Return - Amendment

Mr Ben Morton, the party agent for the Liberal Party of Australia (Western Australian Division), gave notice under section 175X of the *Electoral Act 1907* that the amendment to the return lodged on 20 December 2013 with the Western Australian Electoral Commission (the Commission) was impossible to complete, despite subsequent amendment, as he was still unable to obtain particulars that were required for the preparation of the return.

Mr Morton identified that he believed on reasonable grounds that an individual that he named in the notice would be able to provide the Commission with the necessary particulars to complete the Liberal Party of Australia's (Western Australian Division) annual return for 2012-2013.

The Commission will contact the individual named to seek the supply of those particulars identified by Mr Morton.
