Thank you for the briefing on proposed changes to the Electoral Act last week. I will respond as soon as possible.

This letter is to confirm, as discussed, that an error in our 1997-98 annual return has been brought to our attention following a recent audit by the Australian Electoral Commission.

A donation of \$50,000 which we believed to be from Westralian Airports Corporation was made by direct bank transfer and not accompanied by any paperwork. We declared the funds to be from Westralian Airports Corporation. However, we have now sourced details of the interbank transfer from our bankers and I can confirm that the donation was made by WAC's parent company, Airport Group Australia Pty Limited, C/- Bank of America, Bank of America Centre, 135 King Street, Sydney 2000.
