OVERVIEW

In late 1998 my personal office computer systems began to fail, shortly (two weeks) after I paid out the equipment leasing contract with "Radio Rentals".

The AEC (WA) were aware of these difficulties, as their offices are close to my local computer (secondhand) parts shop.

The main system failed several times between December 1997 and January 1998. I decided to buy a new system in January 1998, which was purchased on January 23, 1998.

As a result of this equipment replacement/upgrade, the expenditure for 1997-98 is an "abnormal" (once every three to four years only).
