Dear Melinda,

As you know, we recently underwent an audit of the WA State books. The audit was undertaken by Mr Chris Morris of the Federal AEC and his staff. While the Audit was generally okay, there were a number of minor adjustments to be made. Following are the adjustments to be made to the return.

1. As previously advised adjustments needed to be made to the consolidated return due to two branches putting in only half a return, and my error of using a wrong figure on the Head Office return. I have enclosed the return you sent me with the new totals shown in pencil. You have the original full returns.
2. We were not aware that we had to take into account the candidates returns. Enclosed is a report of the income and expenditure relating to all of our candidates.
3. In the 97/98 return, we could not complete a return for the defunct Peel Branch, as there had been a fraudulent transfer of some \$2300 from our authorised account to an account bearing no relation to our Party. Chris Morris can assist us to possibly recover this money, but to do so I have to name the persons responsible, under Section 318 of the Commonwealth Electoral Act. The person who were in my opinion a party to the fraud, were:-
