1. The loan is repayable over a period of four years.
2. The loan is unsecured, and effectively "subordinated" to the ALP (WA Branch)'s commercial debts.
3. The loan is interest-free.
4. The loan was made for a specific purpose.
5. The loan is subject to certain financial performance criteria established by the National Executive of the Australian Labor Party. These criteria include the granting of certain management rights to a sub-committee of the National Executive.
