DISCLOSURE OF EXPENDITURE AND GIFTS FEBRUARY 10TH, 2001 STATE ELECTIONS

BY THE FIVE (5) ELECTION CANDIDATES OF THE "TOPS" GROUP/PARTY - UP TO NOVEMBER 2000 A REGISTERED STATE POLITICAL PARTY

This Declaration covers the State Election specific expenditure - for the period of the February 10th 2001 WA State Election contest - by the TOPS candidates' group campaign; wherein this was a single campaign shared by five (5) candidates.

- This Declaration is common for the five (5) TOPS' candidates.
- Regardless of recent legislative and party registration changes in W.A., at the time of the February 10th 2001 State Election, TOPS was still a registered <u>Federal</u> political party.
- TOPS State, Federal and International is a single organisation. All five (5) TOPS candidates are members of the (Federal) registered political party.
- Mr Finney last stood as a State election Candidate in 1992 (Fremantle by-election).
 The jurisdiction of the WAEC does not compass the Federal Act, and is retired where the two conflict.

Within the statutory electoral period - 1996 ~ 2001 - no TOPS candidate was a "prior electoral candidate" at State (WA) level and within the Statute of Limitations.

TOPS has (and will continue) lodged annual Federal/State funding returns to the AEC
 for every due period - since registration.

These have been provided to the WAEC, because the funding and expenditure (State/Federal) is the same (no delineation).

Other than expenditure upwards of \$500, over six months June 2000 ~ December 2000, trying unsuccessfully to gain documentation/detail from the WAEC itself - where the same (\$500) was costed within normal procedural accounting - TOPS received and spent nothing on WA Election specific campaigning, not costed previously in our return for the 1997-1998 financial year (original registration).

- Much of the equipment and documentary preparation for the February 2001 WA
 Election was negated or fruitless, through lack of co-operation by the WAEC and
 through legislative changes, for example: early campaign documentation prepared up
 to October 2000, was all abandoned/re-written.
- Specific computer upgrades and scanning/OCR equipment to transcribe electoral lists for electorate use - was wasted or not used, because the WAEC refused to provide the majority of these, until the evening before the poll (when they were bloody useless).
- Due to the scope and nature of TOPS' work, along with that of the five (5) TOPS' "unregistered" State candidates, it is difficult to specifically delineate or assign a particular expenditure item solely for State Election purposes.

For example:

- I might see several business people on a trip into the City, plus a WAEC officer or campaign related matter.
- TOPS equipment/infrastructure is not solely dedicated to WAEC matters/campaigning, while remaining the property of TOPS members - who provide its use for the purpose of TOPS' activities.
- Air travel to Perth (Ray Kennedy) included appointments for Station specific, Order of St John specific and family care specific matters.
- The political pages on the Roy Hill Web Site are not the primary or principle purpose of that Site, just as Perth Web's charges and programmes are not State Election exclusive.
- TOPS' candidates took no public donations, and funded the joint campaign from our own pockets and without thought of recompense/reimbursement... thus our return is an estimation (as accurate as possible), for the purposes of probity and public record.

"Precise" means accounting for each piece of toilet paper, or tea bag, which no party/candidate does - and cannot be reasonably expected, or requested.

Where in doubt, TOPS has costed upward (e.g. phone and fuel, election specific, for Roy Hill), to avoid under declaration.

For public purposes, this (combined) declaration is accurate (minimum), and there was zero/nil external funding/donations.

ADDITIONAL

Over the last three years, TOPS (Oceania) has sponsored several "Tee Shirt" campaigns. These were all Federal and International issues, with the exception of:

- i) Roy Hill/Fortescue River pollution campaign (environmental/industrial)
- ii) "Bondy's Bells" Tee Shirt and banner plane (public/corruption).

These are campaigns to publicise the issues and are not State electorate specific; however, for the record:

- a) A budget of \$5,000 was allocated to heighten public awareness of pollution of the Fortescue and Fly Rivers (i.e. Roy Hill and OK Tedi).
 - To October 2000, \$3,800 had been spent producing hats and Tee Shirts, for Australia, Europe and New Guinea.
- b) A budget of \$5,000 was allocated to draw public attention to the Bell Tower inappropriate funding priorities.
 - To December 2000, \$2,500 had been spent on Tee Shirts, a banner plan and associated documents/postage, for WA and Europe.

The budget funding for these public campaigns is provided by RR and MA Kennedy - TOPS members - as a community/social service.

N.B. "Vote Kennedy" on the OK Tedi caps is a Federal (AEC) application (International and Environment.)

All Tee Shirt campaigns (provision/distribution) was suspended from January 2001 to March 25th, 2001, covering the WA Election campaign (primary) period.
