

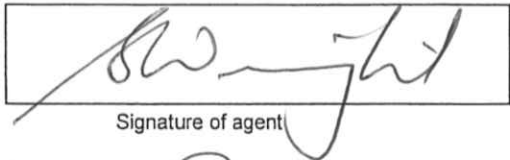

SUMMARY OF EXPENDITURE INCURRED IN RELATION TO THE ELECTION
