Introduction



2014-2015 Political Finance Annual Report

The Western Australian political finance environment increasingly reflects a surge of activity in anticipation of the next State election to be held in 2017. As a result, the Western Australian Electoral Commission (the Commission) has been reviewing means of assisting political parties and their associated entities to achieve their compliance obligations. Challenges are particularly relevant to those parties that are not listed in the register of political parties and whose activity and presence at a State level is not easily qualified.

The increasing political activity may explain the larger number of unregistered political parties that submitted annual disclosures for the 2014–2015 financial year. In spite of this, no political parties were added or removed from the political parties register during the 2014–2015 financial year. Political parties continue to meet lodgement obligations as specified by the *Electoral Act 1907* (the Act). However, late changes and amendments were received by the Commission from some parties pertaining to the 2014–2015 financial year, as well as the 2013–2014 and 2012–2013 financial years.

Political activity does not necessarily coincide with donations and income, as eight of the fifteen political parties that provided an annual disclosure for the 2014–2015 financial year received less than the specified amount of \$2,300 in gifts and other income. These parties, generally, have limited resources such that the administrative ask of compliance obligations can be significant for them. However, the overarching consideration is that donations received prior to an election can still be used for the purposes of the election campaign, regardless of the parties' resources or size. It is in this regard that the transparency and accountability of gifts and income is important.

The 2014 Vasse by-election was the only electoral event in the 2014–2015 financial year that required financial disclosure and where candidates were entitled to submit claims for electoral funding reimbursement. Disclosures relating to the by-election, and claims for electoral funding, were compliant with the requirements of the Act.

This report is prepared to meet the obligation under section 175ZG of the Act to submit an annual report to the Minister, and subsequently each House of Parliament. It does not propose any recommendations, although the Commission continues to support the recommendations contained in previous reports. Data provided in financial disclosure returns, as well as copies of the returns, are detailed online on the Commission website, www.elections.wa.gov.au.

1. Financial disclosures

1.1 Annual returns by political parties and associated entities

- \$8,272,244.98 in gifts and other income was declared by 15 political parties.
- \$3,634,627.00 in gifts and other income was declared by five associated entities.
- One annual disclosure was received four days after the deadline.
- One political party submitted an amendment to their 2014–2015 disclosure in March 2016.

- The Federal election and Senate re-count was held during the 2013–2014 financial year.
- Two amendments were received for the 2013–2014 financial year. The table above includes the updated figures for the 2013–2014 financial year.
- The Vasse by-election was held during the 2014–2015 financial year.

Two amendments were also received for the 2012–2013 financial year. The total gifts and other income, for the 2012–2013 financial year, declared by political parties is \$20,677,384.32 and by associated entities is \$1,396,210.00, including the amounts contained in the amendments.

Political parties and associated entities are entitled to meet their State disclosure obligations by lodging the same return prepared for the Australian Electoral Commission under the *Commonwealth Electoral Act 1918*¹, if they are obliged to submit a Federal return. Three registered political parties met their disclosure requirements by submitting their Federal return for the 2014–2015 reporting period.

¹ The CEA disclosure threshold for individual donations for 2014-2015 was \$12,800, whereas the State threshold was \$2,300.

1.2 2014 Vasse by-election

The by-election was held on Saturday, 18 October 2014. Candidates and political parties had until 15 weeks after polling day, or 2 February 2015, to submit their by-election disclosure returns to the Commission. These returns were available online for public inspection 19 weeks after polling day.

- \$1,500.00 in total gifts was declared.
- Gifts not disclosed by party-endorsed candidates are incorporated into the annual return of the relevant party.
- \$193,424.79 in electoral expenditure was declared.

1.3 Part VI disclosures

- Three political parties updated their party agent details.
- One political party changed its party secretary.
- 152 public agencies disclosed to Parliament expenditure of \$88,260,545.65 relating to advertising agencies, market research, polling, direct mail and media advertising agencies.

2. Public funding

Reimbursement of electoral expenditure is authorised where the candidate has received more than four percent of the total formal votes. The figure to be reimbursed is the lesser amount of electoral expenditure or the amount determined by using the public funding figure (\$1.83007) per first preference vote received. Eligible candidates, or their party agent, were required to submit a claim within 20 weeks after polling day in order to receive any public funding for the Vasse by-election. Four candidates qualified to claim reimbursement of electoral expenditure, however, one claim was received after the deadline. The three eligible claims were finalised by 13 February 2015.
